### SECTION 4: First aid measures

#### 4.1. Description of first aid measures

- First-aid measures general : Never give anything by mouth to an unconscious person. If you feel unwell, seek medical advice (show the label where possible).

Potential danger from aspiration must be weighed against possible oral toxicity when deciding whether to induce vomiting.
